



## **HISTORIC CHARGE OUT RATES**

An objective and practical approach has been taken to each case which included active Partner/Managing Director's involvement from the outset. Other members of staff have been assigned on the basis of experience and specific skills to match the needs of the case.

Work undertaken has been recorded in 6 minute units in an electronic time recording system. Time properly incurred on cases was charged at the hourly rate of the grade of staff undertaking the work that applied at the time the work was done.
